CONDITIONS UPON WHICH CREDIT WILL BE GRANTED

Cape Cod Ready Mix Inc. will grant credit on the following terms and conditions. By applying for credit, and executing this form, you are agreeing to abide by these conditions which will act as an agreement between your company and Cape Cod Ready Mix Inc..

All balances over 30 days shall bear interest at the rate of 1.5% compounded monthly, for a total annual interest rate of 18%.

There shall be a \$50.00 penalty charged for any and all returned checks.

Statements of your account will be mailed to you at mailing address. If, when you receive your statement, you see any error or discrepancies you will notify us of those errors within that billing period.

You will make your payments on this account by delivering them to PO Box 399, Orleans, MA 02653. To qualify for the discount, payments must be received at this address by the due date.

Your account will first be credited for interest due with the remaining portion of the payment being applied to your invoices. Your account will be in default if you fail to pay your oldest invoices within 45 days of their issuance.

Cape Cod Ready Mix Inc. reserves the right to waive any of these conditions, but waiver at any time shall not constitute grounds for waiver in the future on any such term or condition.

In the event that your account goes into default, you will be responsible for the balance due, interest, and all costs of collection, including reasonable attorney fees.

You will provide Cape Cod Ready Mix Inc. written financial statements of your company within thirty (30) days of its request.

By executing this application, you agree that Cape Cod Ready Mix Inc. can contact your references and inquire about your credit worthiness now and while this agreement is in effect.

Your right to purchase product from Cape Cod Ready Mix Inc. on credit is conditioned upon your performance under this agreement. Cape Cod Ready Mix Inc. shall not be required to sell you product for credit if you are in default under this agreement, if you fail to comply with these conditions, if you file bankruptcy, your company is placed into receivership, reorganization, involuntary bankruptcy, or executes and assignment for the benefit of creditors.

You recognize that Cape Cod Ready Mix Inc. may require some form of collateral in the event that you desire to purchase product above your credit limit. You agree to provide that collateral upon request of Cape Cod Ready Mix Inc. You further recognize that Cape Cod Ready Mix Inc. may record materialmen's liens, as provided by Massachusetts law, for any of your jobs. You will agree that you cooperate with them in the filing of those liens.

You further recognize that Cape Cod Ready Mix Inc. may require your account to be personally guaranteed by you or a third party before agreeing to enter into this credit agreement. You agree that you will provide all guarantors with a copy of this contract before they execute the guaranty.
